Yet we are pleased to report another successful year for H&I. Our focus

is to continue building on the excellent teamwork we worked so hard to achieve. Again, your support is the anchor that sustains our legacy, and we need your participation to keep "Dear Ole H&I" going strong. Let's work together and focus on making 2023 another stellar year for the Association.

## Let's begin with a Review of 2022 H&I Membership Support

The Big Story for the year 2022 revolves around the tremendous commitment demonstrated by our members in sustaining the H&I operational objectives. Our H&I member volunteers led by Museum Chairperson K. Johnson supported the Association in a variety of ways; D. Justice managed all incoming calls to the Association through closure; C. Cheek volunteered to organize the 2022 Reunion Golf Tournament; L. Carroll, Rose Bullock, Mr. & Mrs. M. Anderson, Richard Bullock, Mr. & Mrs. James Henderson, R. Kingsberry, H. Richardson, O. Terry, supported the successful reopening of the Museum; and R. Bullock, V. Traynham and I. Kingsberry focused on content review management of the website. It was amazing to witness such dedication, and selflessness in assuring the success of "Dear Ole H&I." Words cannot express our feelings, nor our thanks for all your help.

#### **Association Financial Management**

The Association experienced another strong year managing the finances. Our Financial Secretaries, J. Hodge, and B. Crews, and our Treasurers, L. Terry, and D. Henderson, continued to exhibit exemplary

performance in the management of all Association and

Museum transactions. All accounts receivable and accounts payable were delivered accurately and on time.

### **H&I Museum Funding Request**

The Association officers completed a Request for Proposal in Pursuit of State funding for the H&I Museum. The proposal was submitted, accepted, and forwarded for processing to the N.C. State Appropriations Committee in July of

2022. During our September 3, 2022, Class Reunion Business Meeting, Representative Garrison informed membership that the funding request was on track. Unfortunately, Rep Garrison will not be returning to the State Legislature. He has suggested that we contact legislators with experience and seniority to continue to track the request. H&I officers will determine how we plan to proceed.

#### Dr. Andrea Harris, Class of 1966, Honored

In 2022, the Association was asked by Henderson City Councilwoman, Marion B. Williams, if it would support a recommendation to name a section of I-85 in Henderson in honor Dr. Andrea Harris. A positive letter of support was submitted, and the state approved the recommendation.

#### **Local Churches**

The president of the Local Ministers Alliance reported in September 2022 that they were in the process of electing new officers and once the process was completed, H&I could present their ASBC-HBCU Scholarship program. The Association plans to meet with President Brooks to advance this program at the church level during this year.

### **Vance County Schools**

Assistant Superintendent G. Powers provided H&I with the principal's names, contact information and the four high schools under her responsibility. Once the Association receives the 2023 information, it plans to reach out to these contacts and introduce the

complete ASBC-HBCU Scholarship details to the principals and their college-bound students.

#### **Bereavement**

Two of our beloved senior leaders, Brother Jamie Burwell and James N. Fuller were called home in August 2022 and January 2023 respectively. They were both truly dedicated contributors with their time, talents, abilities and focused on the success of H&I. Our sincerest condolences are extended to these families. #### **H&I Board Officer Staffing Requirements**

There are several open positions on the Board. Two active H&I members were recently identified and recommended for Board membership. The Committee Chair will be sending out candidate nomination forms to them to be completed and returned in the coming days. The Board secretary position slot is open.



Always faithful to his Alumni Association, Jamie Lee Burwell passed August 28, 2022. He was a member of the Henderson Institute Class of 1957. His wife of 60 years, Edith Brodie Burwell, was a fellow alum.

In 1962 Jamie and Edith migrated to New Jersey where Jamie worked in restaurant management and ultimately with the New Jersey Transit System. Upon retirement they moved to Youngsville, NC to reunite with family and friends.

Jamie was an active member of the New York-New Jersey Alumni Chapter and when he returned to North Carolina, he continued to support his alma mater as a member the Triad Alumni Chapter. He served on both the Executive Board and the Board of Directors. He was always available to help; there was never a task too menial for him. He served willingly and devotedly. His presence and smile will be missed.

## Dr. James N. "Jam" Fuller



Dr. James N. "Jam" Fuller, a 1958 graduate of Henderson Institute, passed January 24, 2023. He resided in Greensboro, NC.

An Air Force veteran, James received his undergraduate and graduate degrees from A & T State University and his doctorate from the University of NC at Greensboro. He spent the entirety of his career in the Guilford County School System. He was a teacher and Asst. Principal and ended his tenure as Director of Community Intervention.

James was a member of Phi Beta Sigma Fraternity, the North Carolina Black Leadership Caucus, and a former member of Rialto Beautiful in Rialto California. He was also a longtime member of Providence Baptist Church, where over the years he served in various positions—Men's Fellowship, Church Teller Captain, Men's Day Program Chairperson, Usher, and Trustee. Providence honored him by awarding him

"Man of the Year.

Always a panther at heart, James was dedicated to his high school alma mater. He was a member of the Piedmont Alumni Chapter, and he served on the Henderson Institute Board of Directors as a member and as chairperson. We are grateful for his service.



# Johnny Plummer Johnson, Jr.

Johnny P. Johnson passed peacefully on November 5, 2022. He was a 1953 graduate of the Henderson Institute.

He earned his undergraduate degree in Art from Virginia State University and his graduate degree of Fine Arts from Howard University. He continued his studies at the Corcoran School of Art. In 1994, he was elected to the Virginia State's Sports Hall of Fame as a legendary basketball point guard.




Johnny was as an outstanding educator who taught on every level from grade school to college. He was the first African American member of the teaching staff at Mary Washington College and was a faculty member at Germanna Community College. His enthusiasm and skills as an educator were recognized by the state of Virginia as its "Teacher of the Year" in 1977. He was the first art teacher to receive this prestigious honor.

A very strong and devout Christian, Johnny joined Shiloh Baptist Church shortly after he arrived in Fredericksburg. He assumed numerous roles over the years, including Deacon, Sunday School teacher, and Sunday School superintendent.

Johnny's community activities were numerous. A devoted life member of the Omega Psi Fraternity, Inc., he received numerous accolades and honors from the Fraternity. He also served as a board member of the United Way, Big Brothers and Big Sisters, and the American Cancer Society. He was also a member of the Fredericksburg Jaycees (one of the first two African American members).

A leader in social issues, Johnny had long been committed to finding common ground between diverse communities. The "first black man" in several institutions and organizations, he brought grace, good humor, and common sense to the table as he publicly expressed and defended his beliefs about the



importance of equality for all. He was an active member of several human relations organizations, including the Fredericksburg Council on Human Relations (which he served as President).

During the civil rights protests immediately following the death of Dr. Martin Luther King, Jr., Johnny founded the Young Men's Club to channel the energy of local young black males into constructive efforts. He was a charter

member of and a teacher at the Harambee 360° Experimental Theater, Inc. He was also a long-time member of the Fredericksburg Branch NAACP.

A revered and respected leader in the Fredericksburg arts community, Johnny was a founding member of the Art First Gallery of Fredericksburg. He was a participant in the U.S. Department of State's Art in Embassies Program and following a visit to Benin, West Africa, he spearheaded an Art for Africa Support group to provide art supplies to struggling artists. His paintings at the official United States residence in Montenegro and his exhibit at the Mutual Art Gallery in Jamaica to celebrate Jamaica's 50th Independence received rave reviews.

Johnny was always very humble about receiving recognition for doing that which he was required and called to do as a Servant Leader. Especially meaningful to him was the Johnny P. Johnson Day, July 7, 2018, and Germanna Community College's 2019 Philanthropist of the Year award. Although somewhat embarrassed by these recognitions, he often remarked that he had been "given his flowers while he could still smell them."

Johnny was a very proud graduate Henderson Institute. He was a charter member of the Board of Directors and an active supporter of the DC-MAC Chapter and the Alumni Association. During the early years of the Reunion, he would raffle one of his paintings to raise money for the museum. He even had an art show during a Reunion weekend. For about ten years, Johnny served as Association Parliamentarian. When allegations made against the Board of Directors were investigated, his compassion and expertise were evidenced. He was a panther who never roared, but his purr was heard by all.

### ANNUAL RECOGNITION AWARDS

**Qualifications:** All nominees must have been a graduate, former student, legacy of or teacher at Henderson Institute.

#### **Procedures**

- 1. The Committee will review how the individual relates to other nominees, outstanding contributions made to the community; chosen profession, and/or career. These are more important than a list of offices held, or honors received.
- 2. Nominations must include a narrative typed or clearly handwritten, double-spaced, but not more than five (5) pages. It should be well organized and neat. It may include: (a) activities that inspired you to nominate the individual; (b) comments about the nominee from employers, peers, co-workers, family and/or a community person. These should be included in the five (5) pages.

The nominee will be notified in writing of his/her nomination, unless specifically requested not to do so by the person making the nomination.

Awards will be presented at the Annual Banquet. A nominee may be submitted more than once for consideration. Yes, a person may nominate him/herself.

Each recipient, or his/her designee, is expected to attend the Banquet at his/her own expense.

### **Award Categories**

Please review each category description carefully before making a nomination.

- 1. **Humanitarian**: A person who has made outstanding contributions to the welfare of humanity.
- 2. **Hall of Fame**: A person having excelled in athletics, education, medicine, business, government, military, etc.
- 3. **Community Leader**: Someone who recognizes a need in the community and takes the necessary steps to meet those needs. (i.e. mentoring "at risk" kids, organizing help for the needy; organizing crime prevention programs, etc.)
- 4. **Service:** Someone who has given outstanding service and support to the success of our Association and/or Annual Reunions.
